Gold Star License Plate Eligibility Requirements

The California Department of Veterans Affairs (CalVet) or designee shall, upon receiving proof of eligibility from an applicant, authorize DMV to issue Gold Star Family specialized license plates. The vehicle must be owned by an eligible family member of a member of the Armed Forces of the United States who was killed in the line of duty while on active duty during wartime service, or during an international terrorist attack that has been recognized by the United States Secretary of Defense as an attack against the United States or a foreign nation friendly to the United States, or during military operations while serving outside the United States, including commonwealths, territories, and possessions of the United States, or as part of a peacekeeping force, which includes personnel assigned to a force engaged in a peacekeeping operation authorized by the United Nations Security Council. An eligible family member is defined as all of the following:

1. A person must have a licensed vehicle registered in California.
2. A person who attaches proof of one of the following relationship to the servicemember identified on DD Form 1300 / or verifiable proof of death in combat:

Fees subject to change based upon legislative action.

Amateur Radio Station	Issued to a person licensed by the Federal Communications Commission (FCC). A copy of the valid FCC license must accompany the application, the plate configuration is the call letter. Licensee may obtain only one set of plates. Fees: Original \$21 Duplicate \$17 Reassignment \$12
Antique Motorcycle	Issued to a motorcycle manufactured in 1942 or before. Fees: Original \$15 Substitute \$17
Congressional Medal of Honor	Recipient of the Congressional Medal of Honor, receives plates at no additional cost. Certification on the application must be completed. A copy of the service record, or a copy of the letter which was given to the recipient awarded the Congressional Medal of Honor, must accompany the application. Fees: None Duplicate \$17
Gold Star Family	Issued to family members of an active duty member of the Armed Forces killed in the line of duty. Family Members as defined in section 5156 of the Vehicle Code. Report of Casualty (DD 1300) form and verification of relationship of the applicant to the deceased from the California Department of Veterans Affairs must accompany the application. Fees: None Reassignment \$15 Substitute \$35
Historical Vehicle	Issued to a motor vehicle manufactured after 1922, which is at least 25 years old or older and of historic interest. Vehicle may only be driven in historical exhibitions, parades, or historic vehicle club activities. For commercial vehicles only: The Certificate of Title must be submitted with the application. Fees: Original \$25 Substitute \$17
Honorary Consul Corps	Issued to vehicle owned or leased by an honorary consular officer. A certified copy of the Letter of Notification issued by the US Department of State denoting the applicant's Honorary Consular status is required. Fees: Original \$40 Renewal \$25 Reassignment \$20 Substitute \$30
Horseless Carriage	Issued to a motor vehicle manufactured in 1922 or prior, or manufactured with 16 or more cylinders before 1965. Vehicle may only be driven in historical exhibitions, parades, or historic vehicle club activities. Fees: Original \$25 Substitute \$17
Legion of Valor	Issued to a vehicle, except motorcycle, owned by an Army, Navy, Air Force Medal of Honor, or Army Distinguished Service Cross, Navy Cross, or Air Force Cross recipient. A copy of the service record or Department of Defense Form 214 must accompany application. Fees: None Substitute \$17
Pearl Harbor Survivor	Issued to vehicle, except motorcycle, owned by a member of the US Armed Forces stationed at Pearl Harbor on December 7, 1941, with an honorable discharge from military service. Certification by officer must be completed on the application. Fees: None Substitute \$17
Press Photographer	One set of plates issued to a vehicle owned by anyone regularly employed or engaged as a newspaper, newsreel, or television photographer. Certification by employer must be completed on the application. Fees: Original \$21 Reassignment \$12
Purple Heart	Issued to vehicle owned by a Purple Heart recipient. Copy of orders, service record, or discharge papers showing Purple Heart Award is required with application. Fees: None Substitute \$17
